COMMITTEE REPORTS, MAYOR'S AND COUNCILLORS' REMARKS:

A. RSC Committees - Mayor McKnight and Councillor McDonald indicated that there were two letters submitted to the Town of Sussex from the Regional Facilities Committee for consideration to add two more facilities to the list of Regional Rec. Facilities: the 8th Hussars Arena and the tennis courts. Sussex will need to decide if they want to have them added to the list or not. This has not been approved yet and just in the discussion stages.

This discussion led to questions regarding Councillors' obligation and Code of Conduct when voting at an RSC Committee or Board they belong to. The CAO will seek clarification on fiduciary responsibility and also addressed Council on proper meeting etiquette, reminding Council of the requirement to address the Chair (Mayor) rather than conversing between themselves. Mayor McKnight tabled the discussion, and proposed to re-address it at a future meeting.

Deputy Mayor Snyder reported that the Solid Waste Committee was going to speak to the RSC Board regarding significant upgrades required at the transfer station building. Councillor Muir attended the Nutrien Centre Board meeting and said it was a positive meeting and that the new Manager is doing a great job considering she did inherit a \$200,000 deficit.

- **B. UMNB Zone Reps** Councillors Ganong and Keith will be attending the Zone 3 UMNB meeting on May 16 in Grand Bay. Other Councillors are welcome to attend but need to register in advance. There will be a presentation on Wildfire Management.
- **C. Valley Waters Advisory Committees** Mayor McKnight indicated that there have been various Advisory Committee meetings and that they anxiously await the results of the survey with hopes to get more copies of the survey out to the public through local churches and organizations.
