COMMITTEE REPORTS, MAYOR'S AND COUNCILLORS' REMARKS:

- A. Mayor McKnight attended a meeting at the Sussex Health Center that was chaired by Horizon CEO Margaret Melanson. He had not been invited but was notified by an attendee and chose to attend on behalf of the residents of Valley Waters. Following the meeting, a Press Release was issued by Horizon which Mayor McKnight feels it is very misleading to the public and does not accurately portray the meeting discussion. A test of the new Virtual Doctor pilot program is expected to begin in August and Sussex is the only hospital chosen. It is unclear where the Virtual Doctors will be located, if they are licensed to practice in New Brunswick, and how they will do Virtual assessments, among other concerns.
- **B.** Mayor McKnight attended one meeting of the RSC Oversight Committee. They are preparing a CEO Performance Appraisal template which has a September deadline. The next meeting is scheduled for next week.
- **C.** Mayor McKnight and CAO Angela McLean have a meeting scheduled with the Belleisle Pool Committee next week to discuss what Valley Waters could do to assist them. Councillor Muir planned with Nutrien Manager to supply Belleisle Pool with supplies at their price. Councillor Muir contacted Linda Watson and she is requesting a list of their available supplies and prices.
- D. RSC Economic Development Committee: Councillor McDonald attended a meeting of this committee on June 25 and indicated the committee is lost in their mandate and what it should be. They had Donald

Hamilton from ONB as well as Charlene Hatt who is the Economic Development person out of St Stephen region assist them.

- **E. UMNB:** Councillors Ganong and Keith attended the Zone meeting. Councillor Ganong offered Valley Waters for the next meeting location. This will be the final meeting for UMNB Resolutions to be considered. CAO Angela McLean indicated that Responsible Government and Finance met prior to Council meeting and proposes to add a Municipal Tax Policy resolution for consideration. The CAO will draft a resolution.
- **F. Responsible Government and Finance**: Deputy Mayor Snyder suggested that a Policy document be drafted for consideration for Councillors who are on committees that pay a per diem, and that an annual in-house nomination and vote be taken to ensure that everyone has an opportunity for not only the per diem but also the opportunity to join a new committee to educate themselves on other aspects of municipal governance.
