**CAO's REPORT:** Councillor McDonald asked about the efficiencies found for our phone system. These were cutting back on number of redundant lines and bundling of services. Councillors McDonald and Ganong wanted more information on why some of the RDC applications were not approved. The CAO explained that RDC only covers a portion of costs, not 100%. Councillor Ganong asked if Canada Summer Jobs is replacing the SEED Program and CAO explain Canada Summer Jobs is Federal and SEED is Provincial, and we will apply for both. There was a discussion on the request for a crosswalk at BES and BRHS. It was suggested that if the school board and parents of the students also submit the request to DTI, there might be more success. Councillor Muir asked about the RSC non common services. The CAO confirmed that they are included in the 2025 RSC budget.
