COMMITTEE REPORTS, MAYOR'S AND COUNCILLORS' REMARKS:

A. RSC Committees: All meetings remain on hold.

- **B.** UMNB Zone Reps. There is a meeting scheduled February 20 at 7pm in Grand Bay and will be bring 3 items to the meeting in hopes of having them added 1) farm plastics, 2) approve communication with DTI, and 3) better cell and internet services. Councillor Ganong, unfortunately, is unable to attend Advocacy days as scheduled so there is a spot open if someone wished to attend.
- **C.** Valley Waters Advisory Committees. The minutes from Way of Life Advisory Committee and Strong and Vibrant Communities Advisory Committee are included in the package tonight. Dwayne Boyd has resigned from Strong & Vibrant Communities and will be greatly missed but wish him the best on his future endeavors. Frank and Julie VanderLaan will no longer be on the Economic Development Committee due to a recent move outside Valley Waters.
- D. Teladoc Program at Sussex ER— Mayor McKnight gave his input and support on the test pilot of this service at Sussex Health Center. Deputy Mayor Gillis shared a resident's not-so-pleasant experience with the service and Councillor Keirstead shared her positive experience. As Mayor McKnight pointed out,

every situation is different and the patient, in the end, is responsible for their care and need to speak up for themselves.

E. Sussex Flood Mitigation Plan – The Mayor reported that a public zoom meeting was hosted by the Impact Assessment Agency of Canada (IAAC) concerning the flood mitigation plan for Sussex. Ben Whalen from KRWC had submitted a list of questions, including two issues which might affect Valley Waters - those being potential erosion downstream as well as concerns about the runoff from farms that could flow into the Kennebecasis River. The IAAC will determine if a full environmental impact assessment needs to be completed.
