A Regular Meeting of Valley Waters Council was held on May 13, 2025, 7:00 P.M. in Council Chambers of the Municipal Building. Those present were Mayor Randy McKnight, Deputy Mayor Carey Beth Gillis, Councillors Harold Keith, Charity McDonald, Mary Francis Keirstead, and Lindsey Ganong. Presentation – Vanessa Coggan, Sussex and District Chamber of Commerce re: the 2024 Annual Report. Vanessa presented the Annual Report, highlighting the relationship with the Kings RSC for economic development. Council asked if Vanessa knew how many businesses in Valley Waters are currently registered with Sussex Chamber and how many are registered with the Hampton Chamber. She will collect the data and report back to the CAO.

CAO's REPORT: Following presentation of the report, Council posed questions regarding tax subunits. Councillor Ganong asked for clarification on whether this was already voted on at Budget time. The CAO explained although tax rates may be the same, the subunits still have their own individual budgets. Merging the subunits (budgets and tax rates) is a different process that will require a Special Meeting before June 11.

Councillor McDonald asked what a copywriter does, and the CAO Angela explained that they research and write the content for our website. Councillor Keith inquired about the status of the property at 12 Church St. and the CAO indicated that it's an ongoing file. Deputy Mayor Gillis asked if the RSC applied for ETF funding for a Solid Waste study and the CAO responded that they were not approved for an ETF grant, and we have no indication as to whether they applied for this or other funding. Councillor Keirstead inquired about the potential for bacteria in the water at the Hatfield Point recreation site and Mayor McKnight responded that the Belleisle Watershed Coalition and NB Dept. Environment keep a close eye on the activity at this site and others and inform the public when it is unsafe. Councillor Keith asked if there has been any development on the new subdivision on Route 865, and it appears the land clearing has begun.

COMMITTEE REPORTS, MAYOR'S AND COUNCILLORS' REMARKS:

A. RSC Committees: All meetings remain on hold during the Trusteeship. Councillor McDonald had her private Teams interview with the mediator last week and Mayor McKnight is scheduled for this week. Originally the format was going to be a group meeting but was changed to one on one. Mayor McKnight feels they are behind on the original timeline that was forecast by the Trustee.

B. UMNB Zone Reps. UMNB held their April 17 meeting here at Valley Waters and Councillors Keith and Ganong attended. There was a quick update on Fiscal Reform, and UMNB is still advocating on the issue. There were discussions concerning highway use permits, as a group of recreation vehicles are currently accessing Main St. in Sussex and they hope to extend this in other areas. The next meeting will be at the end of summer. Deputy Mayor Gillis attended a UMNB Teams meeting to vote on updated By-laws,

discussions surrounding the assessment freeze, and decrease in assessment appeals. The freeze includes industry as well.

C. Way of Life Advisory Committee next meeting is the 22nd of May.

E. Strong and Vibrant Community Advisory Committee – there's a need for promoting Dial A Ride and recruiting volunteers. The local food bank is going strong and shows there is a need in our area. Bill Olivier is hosting a breakfast at Valley Waters on Monday 19th supporting local food banks. Mayor McKnight reached out to see if that will include our local one as well, but he has not heard back.
